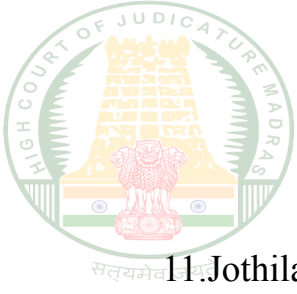

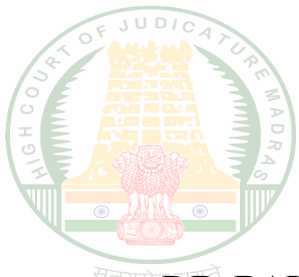

Today, this matter is listed under the caption 'For being mentioned' at the instance of the learned counsel for the petitioner.

2. It is brought to the notice of this Court by the learned counsel for the petitioner that at paragraph no.4 of the order dated 26.06.2025 disposing of this civil revision petition, instead of “the District Munsif Court, Sriperumbudur”, being directed “the District Munsif Court, Villupuram” has been wrongly directed to expedite the trial in O.S.No.63 of 2008 and further, at the same paragraph, the word “dispose” has been wrongly typed as “depose”.
