By consent of learned counsel on both sides, this writ petition is taken up for final disposal at the admission stage itself.



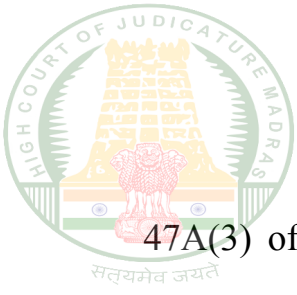
