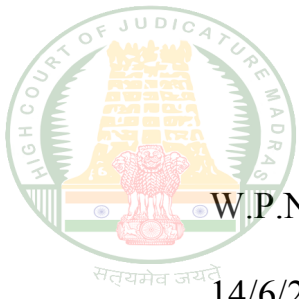

ORDER

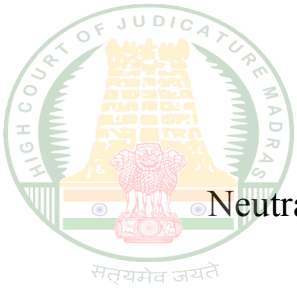
5. With the above direction, this writ petition is disposed of. No costs.
