In such view of the matter, without going to the merits of the writ petition, this Court deems it appropriate to direct the petitioner to give a representation to the Disciplinary Authority within seven (7) days from the date of receipt of a copy of this order. On receipt of such representation, the Disciplinary Authority is directed to dispose of the same in accordance to its own merits and in accordance with law of course by taking into consideration G.O.(Ms).No.81 dated 04.08.2022 within a period of four (4) weeks from the date of receipt of a copy of this order.

6. With the above observations, the writ petition stands disposed of. No costs. Consequently, the connected miscellaneous petitions are also stand closed.
