3. This Court on 24.07.2024 had passed the following order:

“5.Considering the limited relief sought for in this writ petition, this Court without going into the merits of the case directs the official respondents to consider the representation of the petitioners dated 10.06.2023 and pass appropriate orders on the petitioners' representation with regard to omitted extent of the acquired land, on merits and in accordance with law. Such exercise shall be completed within a period of two months from the date of receipt of copy of this order.”
