3. The issue involved in the present writ petition is covered by the earlier orders passed by this Court wherein this Court made it clear that the respondents will have to adjust the current consumption charges from the security deposit that is already available with the respondents.

4. The learned Standing Counsel appearing on behalf of the respondents also submitted that such adjustments will be made from the refundable security deposit that is available in the account of the petitioner.

In view of the above, this writ petition is disposed of with a direction to the respondents to adjust the current consumption charges from the solar security deposit which is already available with the second respondent, until the entire amount is exhausted. No costs.
