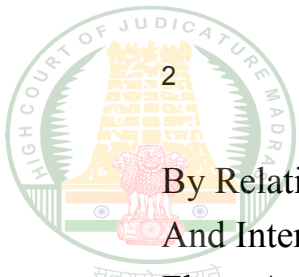

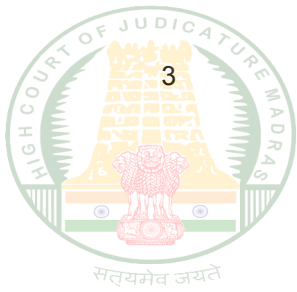

This Civil Miscellaneous Petition has been filed to condone the delay of 143 days in filing the above appeal.

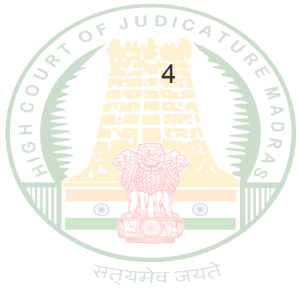
