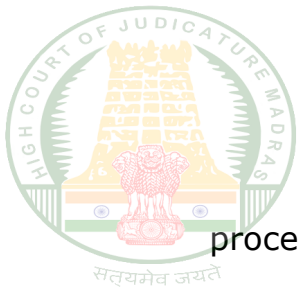

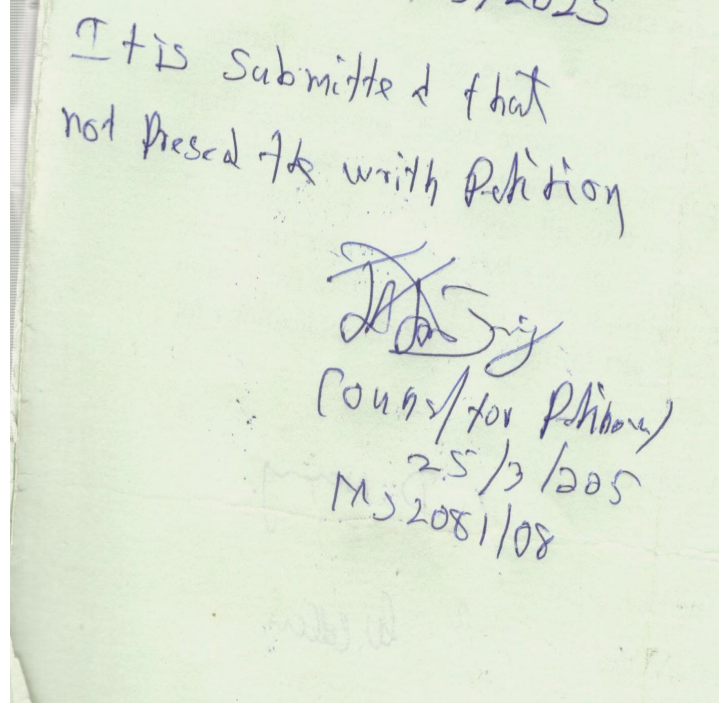

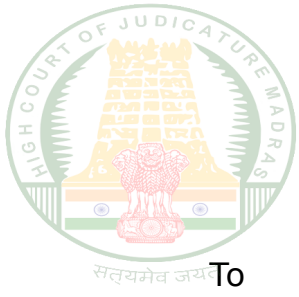


3. In the light of the narrative thus far, captioned main WP and captioned WMP thereat are disposed of as withdrawn/closed. There shall be no order as to costs.
