The learned counsel for the petitioner submitted that the writ appeal filed challenging the orders passed in the Writ Petition has been dismissed on 10.03.2025.

“ 4. The Management will repay the amount recovered from the respective workmen within a period of eight weeks from the date of receipt of a copy of this order. Failing which, the Management will pay interest at 6% on the amount recovered from the date of recovery till date of payment. ”
