6. With the above observations, the writ petition stands disposed of. No costs. Consequently, the connected miscellaneous petition stands closed.

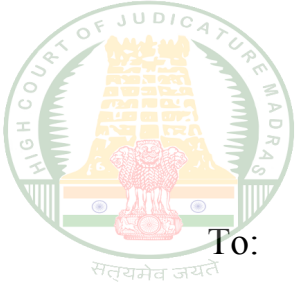
