Mr.V.Gunasekar, learned Standing Counsel for the 2nd respondent, upon instructions, would submit that the application for consent by Mr.V.S.Senthilkumar to establish the Crusher Unit in the name of M/s.Sri Selvakumarasamy and Co. was rejected and therefore, the said unit has not been established.



3. It is stated that the fly ash brick manufacturing owned by Mrs.Geetha in the name of M/s.Selvakumarasamy and Co. is functioning at the adjacent site and there is no complaint against the fly ash brick manufacturing unit.
