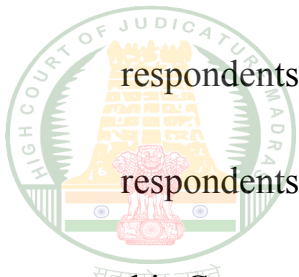
The present application has been filed to grant leave to institute the above said suit before this
