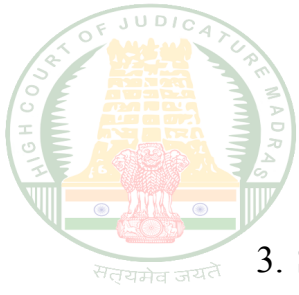

2. When the matter is taken up for hearing today, the detenue is produced before this Court. We have interacted with the detenue, who is now aged about 17 years and she has stated that she is not willing to go with her mother. Now, she is staying in the Home.



3. Since the detainee is not willing to go with her mother, the detainee is directed to remain in the Home until she attains the age of majority.
