ORDER

This Criminal Original Petition is filed to direct the respondent-Police to conduct proper investigation and file final report before the concerned Magistrate Court, pursuant to the FIR registered in Crime No.145 of 2022 on the file of the respondent-Police.

2. In the earlier occasion on 23.07.2025, this Court directed the learned Judicial Magistrate – IV, Puducherry to file additional report regarding status of the arrival report submitted by the respondent-Police, which shows that the additional report/papers in Crime No.145 of 2022 on the file of the respondent-Police, had been filed on 28.12.2023 itself and the matter was directed to be listed on 31.07.2025.

3. As per the directions of this Court dated 23.07.2025, the learned Judicial Magistrate – IV, Puducherry filed an additional report, dated 30.07.2025 in No.198/JUD/JM-IV/PDY/2025 and submitted that, on further checking on the status of the charge sheet filed, as reported by the respondent-Police, a charge sheet has in fact been submitted by the concerned Police with a requisition for further investigation under
