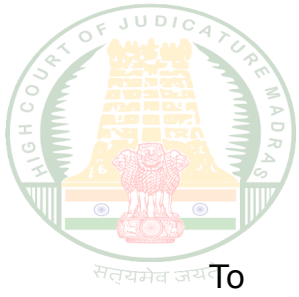
7. Learned State counsel and also learned counsel for private respondent (eighth respondent) do not oppose the captioned writ miscellaneous petition.
