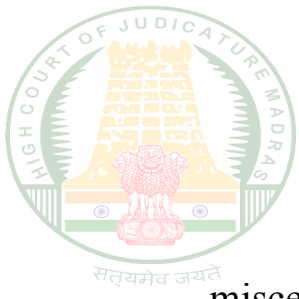

2. The Writ Petition is allowed. Consequently, the connected miscellaneous petition is closed. No costs.

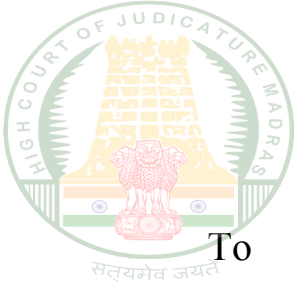
