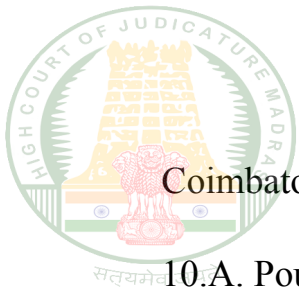

This Civil Miscellaneous Petition has been filed to condone the delay of 138 days in filing the above appeal.

2. Heard the learned counsel for the petitioner and the learned counsel for the respondents and we have perused the materials on record.

3. Considering the submissions and the reasons stated in the affidavit, this Court is of the view that the delay may be condoned on payment of costs.
