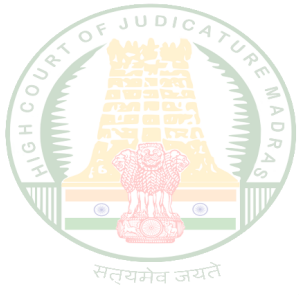

ORDER

The petitioners, who apprehend arrest at the hands of the respondent for the alleged offences under Sections 64 and 318(2) of BNS in Crime No. Not known of 2025, seek anticipatory bail.

2. Learned Government Advocate (Criminal Side) appearing for the respondent Police submitted that CSR enquiry is pending against the petitioners in No.384 of 2025.

3. Recording the submission made by the learned Government Advocate (Crl.Side), it is hereby directed that the respondent police has to issue notice under Section 35 of BNSS (41A of Cr.P.C) to the petitioners and the petitioners are directed to appear before the respondent police and the Investigating Officer has to conduct the enquiry by strictly following the procedures therein and if any *prima facie* case is made out against the petitioners, register the F.I.R or close the petition enquiry within a period of **three weeks** from today.
