issuance of writ of Mandamus directing the respondents herein to consider the representation of the petitioner dated 22.04.2025 and to take appropriate action on the same and pass orders.

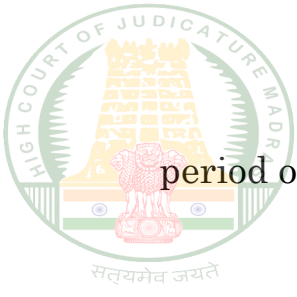

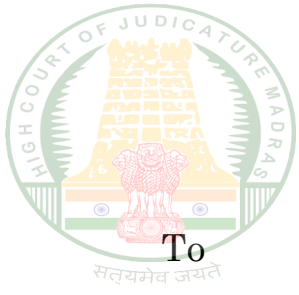
