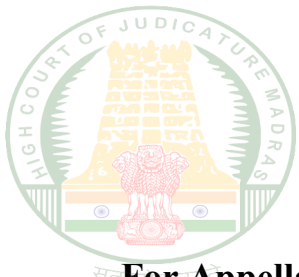

2. From the cause list, it is found that the sole Appellant died and steps were taken.

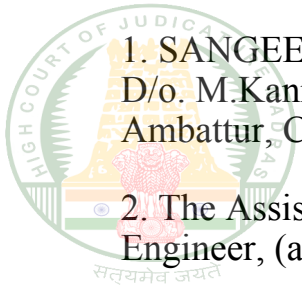
Since notice was served on the other side, the Respondent's names has been printed in the cause list, none appeared on their behalf.
