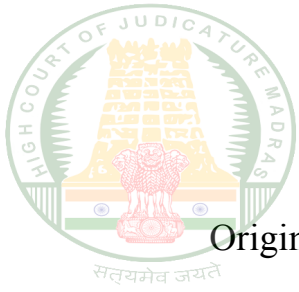

COMMON ORDER

By these applications, a thirty party seeks to be impleaded in Arb.Appln.No.821 of 2025 and O.A.No.634 of 2025. The applications are filed on the basis that an order of interim injunction restraining the 2nd respondent from removing the cargo from the Chennai port was applied for and obtained although the cargo is owned by the third party applicant.
