ORDER

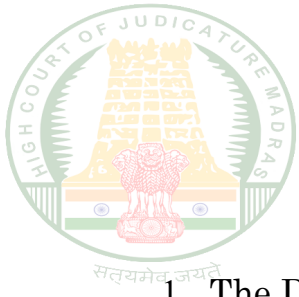
Learned counsel for the petitioner seeks permission to withdraw this writ petition and he has made and endorsement in the court bundle to that effect.
