PRAYER

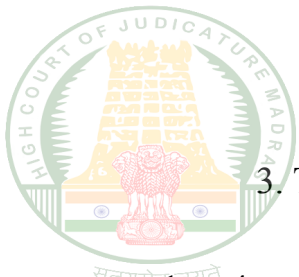

ORDER
