On a reading of the order passed by the learned Magistrate, dated 10.01.2025 in Crl.M.P.No.76134 of 2024, it is seen that the direction was given to the first respondent-Police to conduct a detailed enquiry on the complaint of the complainant and in the course of enquiry, if any material evidence is found, then the Inspector of Police may proceed thereon with
