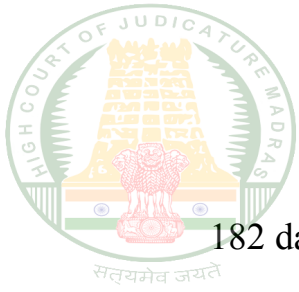

These matters are listed today under the caption “For Being Mentioned” at the instance of the learned counsel for the petitioners.

2. When the matters are taken up for hearing, learned counsel for the petitioners submitted that this Court, while condoning the delay, directed the petitioners to pay Rs.1,000/- to the Tamil Nadu Legal Aid Services

Authority, Chennai on or before 13.08.2025. Since the order itself has been uploaded only on 13.08.2025, the petitioners were not not able to comply with the order of deposit. Therefore, the petitioners sought for extension of time to remit the amount.

3. In view of the above submission, the time for payment of costs is hereby extended and the petitioners are directed to pay costs on or before 26.08.2025 without fail.
