(Order of the Court was made by R.Subramanian J.)

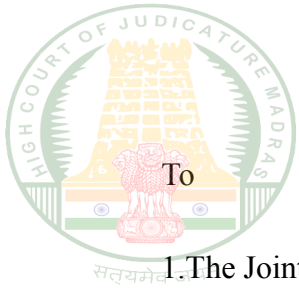
Mr.C.Prakasam, learned counsel appearing for the petitioner would submit that the Writ Appeal itself has become infructuous.
