3. Hence, the same shall stand amended as Judicial Magistrate No.I, Chidambaram and Sethiyathope Police Station, Cuddalore District.

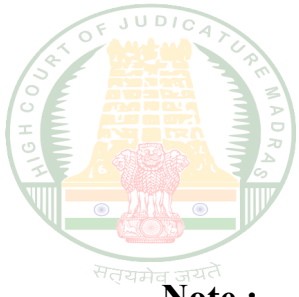
4. Accordingly, this Criminal Miscellaneous Petition is ordered.
