and frivolous information in the social media platforms affecting the public peace.

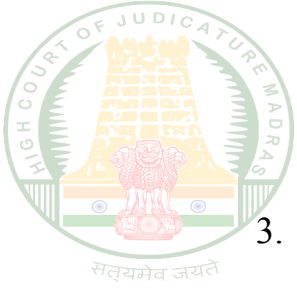
