2. Heard the learned counsel on either side and perused the materials placed on record.

3. The petitioner is a complainant in C.C.No.1062 of 2019, on the file of the learned Metropolitan Magistrate, FTC-I, Allikulam, Chennai. After serving summons to the accused, the accused failed to appear before the Trial Court.
