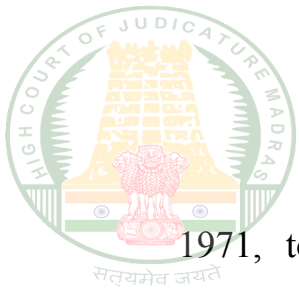

4. In view thereof, this contempt petition is disposed of with a direction to the Authorities to make suitable arrangements or cut the roofings
