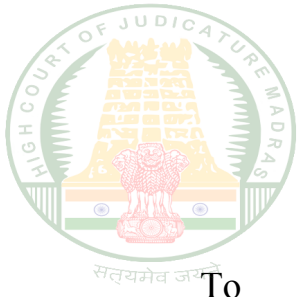
2.Today, when the matter came up for hearing, Mr.S.Udayakumar, learned Government Advocate [Criminal Side] appearing for the respondent/state submitted that the petitioners/A7 in Crl.O.P.No. 5815 of 2024 and the petitioner/A8 in Crl.O.P.No. 5819 of 2024 who had already granted anticipatory bail by this Court, dated 08.04.2024 with certain conditions and the same were not complied with by the petitioners/A7 & A8.
