No costs.

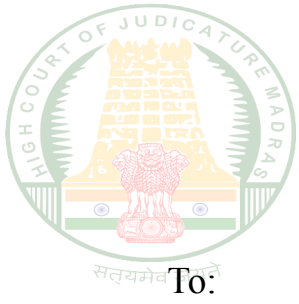
