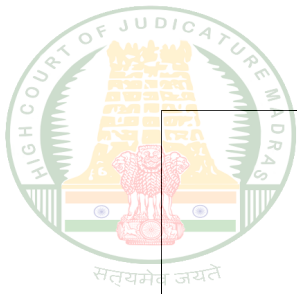

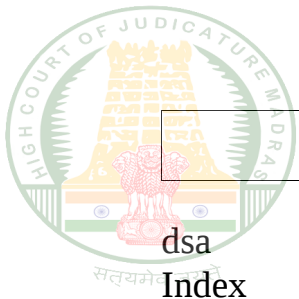
ORDER

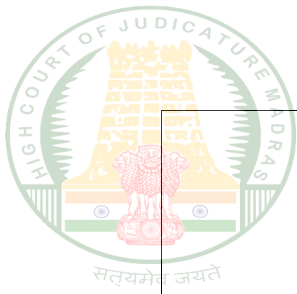

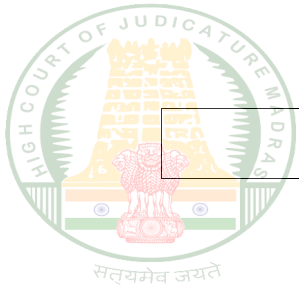
