Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying for the issuance of a direction in the nature of Writ of Certiorarified Mandamus, to call for the records relating to the impugned letter in proceedings No.M.A.6.V.TU.Na.Ka.No.AR1/1028/2021 dated NIL/09/2022, signed on 06.09.2022, and the consequential proceedings in the nature of notice under Section 379 (A) of C.C.M.C.
