4. However, the petitioner is at liberty to work out his remedy in the manner known to law before Magistrate.

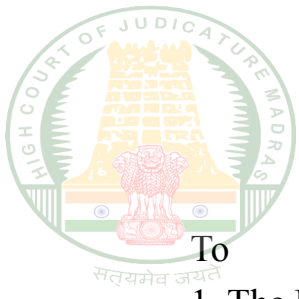
