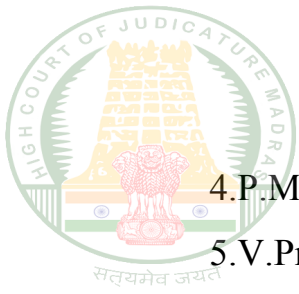

PRAYER: Complaint filed under Order VII Rule 1 of C.P.C., read with Order IV Rule 1 of the O.S.Rules, praying for a judgment and decree as follows:

a) Declaring that the Election conducted and announced by the Election Officer declaring the office bearers for TNGA on 02.11.2021 as null and void as it is contrary to the Bye Laws of TNGA;

b) Declaring that the office bearers elected during the year 2017 are only the duly recognised/ affiliated office bearers of TNGA having Registration No.291 of 1984 to the GFI and TNSOA;



c) Declaring that the elected office bearers of the year 2017 are only competent to file Form VII before the District Registrar Co-operatives, Central Chennai;

d) Mandatory injunction directing the 20th defendant to conduct a fresh election in terms of the bye laws including all the Member District Associations, Office bearers elected during the year 2016 by calling for a General Body Meeting in terms of the Bye Laws;

e) Permanent injunction restraining the elected office bearers of TNGA viz., the defendants 1 to 16 from acting, representing, communicating with anyone as office bearers of TNGA;

f) Directing the defendants to pay the costs of this suit.

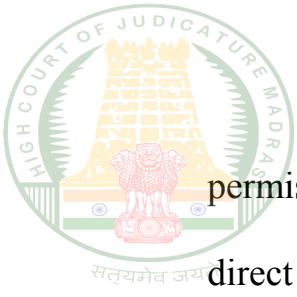

JUDGMENT
