ORDER

The petitioner, who was arrested for the alleged offence under Sections 303(2), 326(a) of BNS, 2023 in Crime No.264 of 2025 on the file of the respondent police, seeks anticipatory bail.

2. The case of prosecution is that on 27.05.2025 the petitioner seized $\frac{1}{4}$ unit of river sand in Ashok Leyland Dost Pickup bearing No. TN-48-BA-8928 without proper permission. Hence this case.

3. The learned counsel appearing for petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case. Hence, he prays for grant of anticipatory bail.

4. The learned Government Advocate (Crl. Side) appearing for respondent would submit that the petitioner seized $\frac{1}{4}$ unit of river sand without any permits and four previous cases pending against the petitioner. However, he vehemently opposed to grant anticipatory bail to the petitioner.

5. Considering the facts and circumstances and considering the period of incarceration undergone by the petitioner, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions.

6. Accordingly, the petitioner is directed to **deposit a sum of**

Rs.5,000/- (Rupees Five Thousand only) as non-refundable deposit to the credit of registered Advocates Clerks Association at Villupuram, and on such deposit, the petitioner is ordered to be released on bail on executing separate bonds for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, for a like sum to the satisfaction of the *learned Judicial Magistrate No.II, Villupuram*, and on further conditions that:

(a) the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(b) the petitioner shall report before the respondent police daily at 10.30 a.m. for the period of eight weeks.

(c) the petitioner shall not tamper with evidence or witness either during investigation or trial;

(d) the petitioner shall not abscond either during investigation or trial;

(e) on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the

conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]***; and;

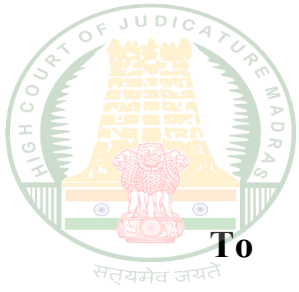
(f) if the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
