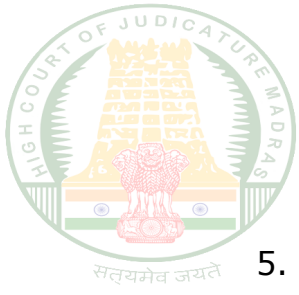
ORDER

3. It is the contention of the petitioner that the 3rd respondent, by falsely claiming that she belongs to the Scheduled Community, has secured appointment in the first respondent department.
