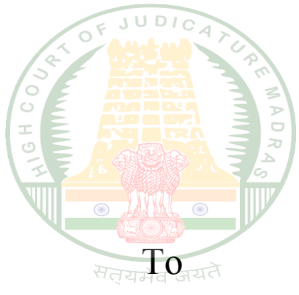
3. The learned Government Advocate (Crl.Side) appearing for the respondent police submitted that the petitioners have been complying with the condition regularly.
