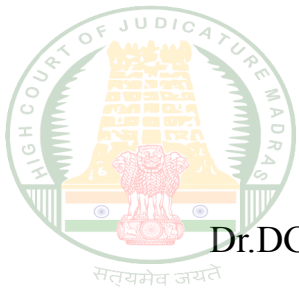

2. In view of the above submission, nothing survives for adjudication in these petitions and the same have become infructuous.

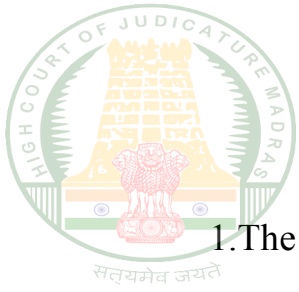
Hence, these transfer civil miscellaneous petitions stand dismissed as infructuous. No costs.
