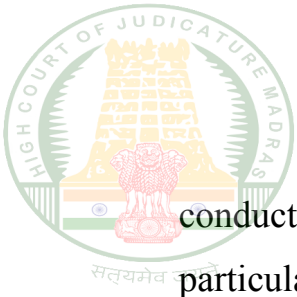

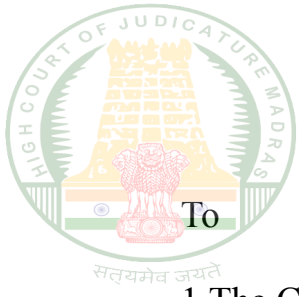
2.In view of the submission and endorsement made by the learned counsel for petitioner, the writ Petition is dismissed as withdrawn.
