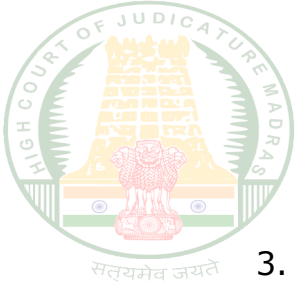


ORDER
