3. When the writ petition was taken up for hearing, learned Additional Government Pleader appearing on behalf of the respondents produced the copy of G.O.(Ms) No.83, dated 26.02.2024. Learned Additional Government Pleader submitted that effective from 01.04.2023, such renewal can be sought for only by submitting an application through online mode. For this purpose, learned Additional Government Pleader relied upon Clause-7 of the said Government Order.

4. In view of the above, it is left open to the petitioner to submit the application through online mode as per the aforesaid Government
