2. Recording the said submission made by learned counsel for petitioner, this Writ Petition is dismissed as withdrawn. No costs.

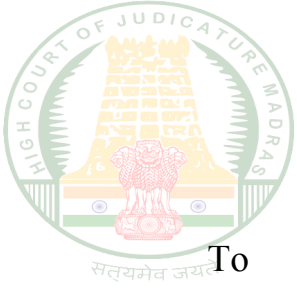
