Order

Mr.Shangarmurali, the learned counsel for the petitioner for the petitioner-Society filed an Additional Typed-set of papers, furnishing a list containing the names of Board Members of the petitioner-Society.

2. However, the learned Government Advocate appearing for the official respondents, viz., respondents 1 to 3 seeks time to verify the said list and report before this Court and hence, seeks short accommodation in that regard. However, the learned Government Advocate would submit that the petitioner-Society is yet to provide the details of Minutes of Meeting of the Board to the Special Officer; that though certain papers are handedover, they are not in a position to verify the same, once, verified and reported, thereafter, this Court shall pass orders for conducting the Board Meeting for appointment of a new set of Office Bearers, so as to manage the affairs of the petitioner-Trust and hence, seeks time for such verification with a condition requiring the petitioner to file all the Annual Reports, including the Balance Sheet, income and expenditure accounts filed before the Registrar of Societies, since, it is alleged that due to failure on the part of the petitioner-Management, in having not properly managed the affairs of the petitioner-Society, the petitioner's Educational Society become defunct; that even assuming that this Court arrives at a conclusion to handover new Management after verification of such particulars furnished by the petitioner-Society by virtue of effecting Gazette Publication and conduct election, the said action has to be recalled by this Court, since only after recalling of the said action,

restoration of the function of the Society, this Court can such orders permitting the Special Officer to conduct election so as to appoint new Board Members of the petitioner-Society.
