This Writ Miscellaneous Petition is filed to condone the delay of 142 days in representing W.P.Sr.No.167617 of 2024 .

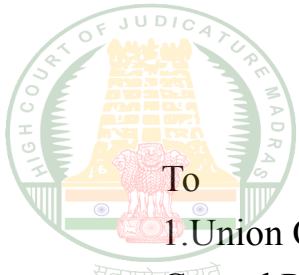
