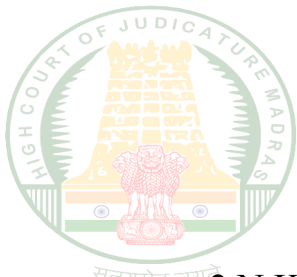

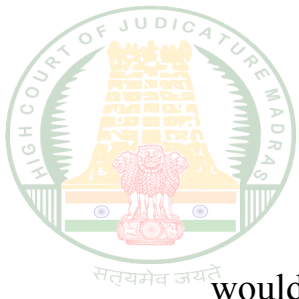
ORDER
