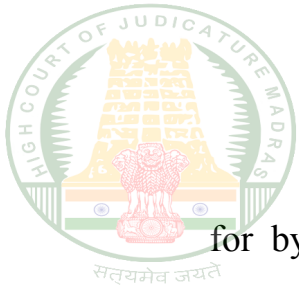

WEB COPY This Criminal Original Petition is filed seeking a direction to the 2nd respondent-Police to file a charge sheet in Crime No.205 of 2024 pending on the file of SIPCOT Police Station, Ranipet District, within a time frame that may be fixed by this Court.

2. Learned Government Advocate (Crl.Side) appearing for the respondents-Police, on instructions, submitted that during the investigation in Crime No.205 of 2024, the second respondent-Police, by letter dated 09.01.2025 sought the petitioner to submit certain relevant documents to investigate the case further. However, the petitioner has not produced the same and due to non co-operation of the petitioner, the second respondent-Police is not in a position to conclude the investigation and file a final report.

Considering the facts and circumstances and also considering the submissions made by the learned Government Advocate (Crl.Side), this Criminal Original Petition is disposed of with a direction to the petitioner to appear before the second respondent-Police and extend his co-operation for investigation and produce the relevant documents as sought
