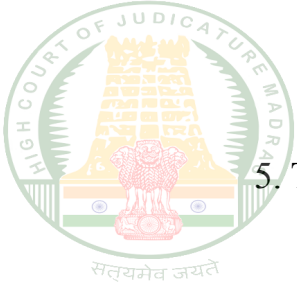

3. The case of the petitioner is that he is a registered cable TV operator and having license for the same. The petitioner submitted an application before the 3rd respondent seeking for approval of the transfer and the 3rd respondent through proceedings dated 01.04.2025 and 21.05.2025, recommended giving the approval and the same is pending before the 1st respondent. Since the 1st respondent did not act upon the recommendations made by the 3rd respondent, the petitioner made a representation on 24.06.2025, which was also not acted upon. It is under these circumstances, the present writ petition has been filed before this Court.

4. Taking into consideration of the facts and circumstances and considering the materials placed before this Court, there shall be a direction to the 1st respondent to act upon the recommendations that have been made by the 3rd respondent through communications dated 01.04.2025 and 21.05.2025 and take a decision within a period of four (4) weeks from the date of receipt of a copy of this order.



5. This writ petition is disposed of with the above directions. No costs.
