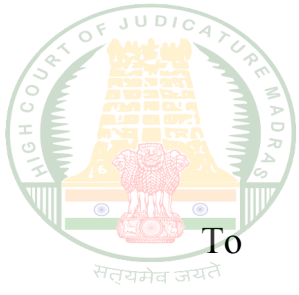
5. This Writ Petition stands disposed of with the above direction. There shall be no order as to costs.
